Your Excellency,

We are honoured by your kind reply.

We are particularly grateful for your concern for whistleblowers that draw attention to the corruption and abuses.

Our impression is that you have been cheated as related to the implementation of the Project on drafting the Anti-Corruption Law on Protection of Whistleblowers, generously supported with EUR 100.000 by Great Britain and the Kingdom of Netherlands.

We kindly remind you that for several members of the working group, appointed by Mr. Rodoljub Šabić, the Commissioner for Information of Public Importance and Personal Data Protection of Serbia, conflict of interest, nepotism and favoritism have been established beyond any doubt.

When we pointed to this cynical absurd, the Commissioner publicly offended us and threatened to bring us to the court of law. By using his position of a state official in such a way, he sided with all those who persecute whistleblowers.

These are the reasons we find impermissible the Commissioner's abuse of the noble donation of British and Dutch tax-payers by arbitrary composing a compromising working group.

We are convinced that in UK, as well as in other EU countries that are based on Acquis communautaire, basic legal standards would not allow such a discredited working group to draft anti-corruptive legislation.

Bearing in mind the unacceptability of double standard principles, we opine that the best support to your excellent
