Predmet: Vanredan stručni nadzor u zdravstvu ne može biti selektivan

Gospođo Đukić Dejanović,

U javnosti je sa odobravanjem zapažena aktivnost MZ u sprovođenju vanrednog spoljnog stručnog nadzora u slučaju sumnje na nestručnu dijagnozu kod jedne pacijentkinje sa karcinomom dojke u privatnoj zdravstvenoj ustanovi.

Takvo promptno delovanje Ministarstva zaslužuje svaku pohvalu.

Stoga vas ponovo podsećamo da postoje zvanični zahtevi za vanrednim stručnim nadzorom i sprovođenjem mera u sledeća dva slučaja sa masovnim ugrožavanjem ljudskog zdravlja i života:

-U trgovini listama čekanja na Institutu za onkologiju Vojvodine (IOV), vanredni spoljni stručni nadzor iz maja 2010. nikada nije završen jer su dva od tri člana komisije uhapšena zbog korupcije. U ovoj aferi oštećeno je više stotina obolelih od raka kojima je uskraćena radioterapija jer su im mesta zauzeli oni koji su platili da se leče preko reda.

Subject: Extraordinary Supervision in Health Care Cannot Be Selective

Dear Ms. Đukić Dejanović,

The general public noticed and approved the Ministry of Health's move for an extraordinary external supervision in order to clarify doubts that a patient's diagnosis of breast cancer has been missed in a private health institution.

Such a prompt reaction of the Ministry deserves all the praise.

This is the reason we remind you again on official requests for extraordinary supervision and action in the following two cases that have resulted in a mass jeopardy of human health and life:

- In the Institute of Oncology of Vojvodina (IOV), an extraordinary external supervision on trading with waiting lists was initiated in May, 2010, but never accomplished, since two out of three committee members were arrested on corruption charges. In this affair, several hundred cancer patients were deprived of radiotherapy because some other people paid to bypass the waiting lists.

- In the Transfusion Service of the "Studenica" Hospital Centre in Kraljevo, the Ministry's inspection has established in June, 2011 that the dialysis solution crystallized, with all grave health

Ova dva drastična primera zahtevaju energičnu reakciju, jer dosadašnja praksa nečinjenja i zataškavanja od strane službi MZ, uprkos svim upozorenjima, neizbežno vodi ponavljanju sličnih masovnih tragičnih pojava. Najsvežiji primer je epidemija hepatitisa C na IOV. Stoga Vas molimo da hitno obrazujete komisije za vanredni stručni nadzor za navedene bolničke ustanove, čime biste poslali jasan znak, kako odgovornima u zdravstvu tako i građanima Srbije, da neodgovornost i kršenje zakona ne mogu više biti pod visokom zaštitom MZ.

These two drastic examples require an energetic reaction, because the current Ministry's administration practice of obstruction and cover up, in spite of all the warnings, inevitably leads to repetition of such mass tragic incidents. The most recent example is an epidemic of hepatitis C in the IOV.

These are the reasons we appeal to you to initiate an urgent extraordinary external supervision in the two health institutions. This way, you would send a clear signal to both health officials and the Serbian civil society that irresponsibility and breaking the law cannot be under the protection of the Ministry of Health anymore.
